

- Investment and/or Technology promotion Delegates from government or semi-government institutions
- Short-term stay in Japan (1-3 weeks)

- Promoting Delegate country and/or specific sectors/projects through seminars, round-table, business meetings
- ITPO Tokyo acts as a hub in establishing human networks between Delegates and Japanese companies
