






Automotive Development Policy (ADP 2016-21)

To increase automotive production gradually by 2021 to:

•Cars /Van/Jeeps: 350,000

Light Commercial Vehicles (LCVs): 79,000

•Trucks: 12,000

•Buses: 2,200

•Tractors: 88,000

Motorcycles:2.5 million

- To increase contribution to the Gross Domestic Product from 2.3 percent to 3.8 percent;
- To increase contribution to manufacturing from 22 percent to 30 percent, and
- To increase direct and indirect employment from 2.4 million presently to 4 million.

- New Investment Incentives
- Five Year tariff plan for existing OEMs
- To curb misuse of Import Policy (vehicles)
- Adoption of UNECE's WP 29 Regulations
- Establishment of Pakistan Automotive Institute
- Ensure Consumer Welfare
- Truck Financing, Incentivizing Fleet Operations

Progress of ADP 2016-21

- Manufacturing license granted to 13 New Companies
- Two closed units revived
- Total Investment 1,167 Bn USD approx
- Volkswagen applied for new entrant status
- Three New Companies already started production
- Capacity enhancement by existing companies Indus Motor Company (Toyota), from 65,000 to 80,000 units/annum recently

Opportunities in Automotive Sector

- Variety due to New Manufacturing Companies: Korean, French, Chinese & Japanese Makes
- Vacuum in market due to surveillance (current imports 75000 units)
- Vehicle Population 16 per 1000 persons
- Increasing income and GDP per capita
- Opportunities in part manufacturing
- Policy under review for benefits to part makers
- Approx 10 Times Large after market
- No vehicle retirement policy, older vehicle more parts required

- Government's resolve to reduce imports, encourage local manufacturing and enhance exports

Export Processing Zones

- Export Processing Zones Authority under MoIP
- EPZs are Developed land on competitive rates for 30 years (as per existing policy)
- Duty-free import of machinery, equipment, materials
- Freedom from national import regulations
- Exchange control regulations of Pakistan not applicable
- Repatriation of capital and profits
- No sales tax on inputs including electricity/gas bills
- Duty-free vehicles allowed under certain conditions
- Domestic market available to the extent of 20%
- Obsolete/old machinery can be sold in domestic market of Pakistan after payment of applicable duties & taxes
