Greetings by Head Seiji Oshima





In 2008, with the kind understanding and the heartfelt support from UNIDO HQ, investment promotion agencies of developing countries, embassies in Tokyo, private business circles and, especially from the Japanese government, UNIDO ITPO Tokyo could function successfully and effectively for the promotion of investment and technology transfer, organizing delegate programmes, seminars, missions and bilateral direct dialogues. On this occasion, I wish to thank all the organizations and persons who have kindly extended their cooperation to our various programmes.

One of the major events in 2008 was Japan's hosting of the Fourth Tokyo International Conference on African Development, TICAD IV, held in Yokohama in May. During this highly visible event, UNIDO ITPO Tokyo had the pleasure to receive UNIDO's Director-General, Dr. Kandeh Yumkella along with a delegation, and to cooperate with UNIDO HQ and numerous important organizations in Japan, including Japanese corporations, universities, etc. and hosted several important activities, interacting with leaders of African countries, as well as numerous high level officials.

During 2008, another area of emphasis was environment related programmes, including technologies related to non-edible based bio-fuels, such as Jatropha, and also banana textile, waste water treatment, and 3Rs (Reduce, Reuse, Recycle) activities. We recognize that environmental protection and environment technologies boast an essential element to promote economic development. Thus, UNIDO ITPO Tokyo plans to increase its activities taking into account environment technologies' importance into 2009 and beyond.

At the moment, although we are facing the sudden global financial and economic crisis, and many obstacles are arising for the implementation of our programmes, we remain convinced that the task of "investment and technology promotion" is one that needs to be undertaken with a mid to long-term view. Therefore, we will do our best through our programmes, and in cooperation with our partners, to communicate business opportunities of developing and emerging countries to Japanese investors, as well as to disseminate the Japanese high potentialities for the industrial development to many developing countries. In doing so, we will closely follow the ideals of UNIDO, which are: poverty alleviation through productive activities, trade capacity-building and energy and environment as one of UNIDO ITPO network organizations.

UNIDO Director-General's Visit to Japan (TICAD IV)

Dr. Kandeh Yumkella, Director-General of UNIDO, visited Japan 27-31 May together with a delegation from UNIDO HQ, on the occasion of the Fourth Tokyo International Conference on African Development (TICAD IV).

The Director-General was a lead-off moderator at one of the sessions "Addressing Environmental Issues/Climate Change, Mitigation, Improving Energy Access". At the side-event "Innovative Approaches to PSD for achieving the MDGs in Africa" co-hosted by UNDP/UNIDO/UNCTAD, he delivered the key note speech. He was also invited as an introductory speaker at the JPC/METI side event "Technical Cooperation on Productivity Improvement in Africa."

The Director-General also attended a breakfast jointly hosted by UNIDO and JGC Corporation, inviting 200 persons, amongst which the Presidents of Sierra Leone and Burundi attended.

Towards the end of TICAD IV, a Japanese traditional happi coat produced out of banana fiber partly from East Africa was presented to the Director-General by Tama Art University. Same coats were also presented to the Presidents of Kenya, Rwanda, Tanzania and Uganda.

UNIDO's unique network of Investment and Technology Promotion Offices (ITPOs) has been constantly expanding to cover the world economy. As of end December 2008, there were 14 offices in Bahrain, Belgium, Brazil, China (2)*, France (2)*, Greece, Italy, Japan, Mexico, Republic of Korea, Russia and the U.K. In addition, 4 smaller offices in Egypt, Jordan, Morocco, and Tunisia, so called Investment Promotion Units (IPUs), plus an associate office in Turkey, provide coverage for the network as well.

UNIDO ITPO Tokyo was founded in 1981 based on an agreement between UNIDO and the Government of Japan.

Besides conventional investment promotion programmes, UNIDO ITPO Tokyo is increasingly focusing on environment related technologies, such as water, environment management, 3Rs (Reduce, Reuse, Recycle), renewable energies, and industrial technologies. Delegates are sought not only for investment promotion, but also for environment technology. As far as regional coverage is concerned, UNIDO ITPO Tokyo continues to cover all developing countries in the world, however, programmes addressing LDCs, especially in Africa, are also highlighted in line with targets of the Millennium Development Goals (MDGs).



ITPO TOKYO SUCCESS STORIES – 2008

Bangladesh: Delegate programme Counterpart: BOI Bangladesh

《Situation Before》

Until quite recently Bangladesh was little known as a business destination among the Japanese business community. Due to the increasing production costs in countries including China, Thailand and Vietnam, the garment industry in Japan has started to look at Bangladesh as a possible location for their business. However, access to information on the investment climate and business opportunities of Bangladesh was still limited due to absence of investment promotion activities in Japan

《Situation After》

The delegate programme for Bangladesh which took place in July 2008 was instrumental in disseminating information on the country's business outlook among potential Japanese investors to Bangladesh. The programme was also successful in providing interested Japanese entrepreneurs with concrete and practical information on how to do business in Bangladesh and convincing them to pay a visit to Bangladesh and study the possibility of developing business in the country.

Co-organized with MOFA (15 February)

The Ministry of Foreign Affairs of Japan and UNIDO organized a major Biofuel Symposium targeting a wide audience of businessmen, policy makers, ambassadors and other diplomats as well as academics, in order to discuss the virtues and possibility to promotion of technologies leading to the production of Biofuel from non-edible plants in developing countries. The event attracted 337 participants.



Biofuel Seminar 4th Meeting in Yokohama (11 July)

The seminar, part of a series and as a follow-up of the Biofuel Symposium in February 2008, was held in Yokohama and discussed the potential of actual project promotion, especially focusing on African countries. Japanese technologies were presented to 86 participants.

Banana Fiber Technology for Rwanda & Uganda

(1-2 July)

H.E. Dr. Emile Rwamasirabo, the Ambassador of Rwanda, and H.E. Mr. Wasswa Biriggwa, the Ambassador of Uganda together with ITPO Tokyo officers visited Tama Art University to meet with professors and students working on the Banana Fiber Project and to learn about the potential to transfer these technologies to their countries. The visits were the basis for the arrangement of further seminars and training activities in the countries from 7-16 October (please see success story on page 10).





Kanazawa (RUM Alliance)

Auto Parts Recycling (7-8 February)

The Head of the office visited the conference in Kanazawa to discuss environmental friendly "auto parts recycling" technology promotion for developing countries. Disposal of auto parts and recycling are part of the eco-friendly 3Rs (Reduce, Reuse, Recycle) concept promoted by Japan. New programmes in this area will be planned in 2009.



The Stockholm Convention

Identifying POPs Reduction Technologies (30 June & 14 November)

Mr. Mohamed Eisa, UNIDO HQ officer in charge of programmes concerning the reduction of persistent organic pollutants (POPs) visited Japan twice in 2008. In cooperation with ITPO Tokyo, Mr. Eisa also held meetings with Japanese companies and government institutions. As a result, a 3rd mission to Japan to visit particular companies and installations (in Eco-towns) is planned in 2009, in order to help promote Japanese technologies in this field.

APPS 2008

Promotion of the Automotive Parts Sector of Developing and Emerging Countries (18-21 June)

Delegates from Argentina, Malaysia, Mexico, Morocco, and South Africa joined the Automotive Parts Product Solution Fair 2008 held in cooperation with Nikkan Kogyo Shimbun (Business & Technology Daily News) and discussed the potential of their countries' automotive and auto parts sectors. The delegates held a total of 25 bilateral meetings discussing investment and technology transfer, and also presented their countries in the Global Auto Parts Business Seminar held on the occasion, which was attended by 170 businessmen. Several Japanese companies visited the delegates in their countries after the programme, and Argentina, Mexico, Morocco and South Africa also held follow-up meetings and seminars in 2008 in Japan as a result of the activity.

ITPO TOKYO SUCCESS STORIES – 2008

Rwanda and Uganda: Banana Fiber Technology Promotion (Green Technology) Counterparts: Tama Art University; KIST & WDA (Rwanda); Ministry of Industry (Uganda)

《Situation Before》

Banana tree stems are usually discarded after they bear fruits at end of their useful life. This results in both unwanted waste, as well as environmental degradation in developing countries and LDCs. In Rwanda and Uganda, countries with abundant banana plantations, the opportunity to use wasted banana tree stems to extract and process the contained fibers with a Japanese technology developed by Tama Art University can lead to the creation of new industries. In compliance with the request of the Presidents of Rwanda and Uganda, the Banana Textile Team composed of three faculties from Tama Art University, one weaving expert from the Tokyo Metropolitan Industrial Technology Research Institute, four students, and two staff members from ITPO Tokyo, were fielded to the two countries to organize seminars and workshops to introduce the concerned technology,

and some selected products.

《Situation After》 The meeting in each country involved a seminar attracting 80 participants each, as well as a banana plantation tour, and a dedicated workshop attracting 70 participants in Rwanda, 60 in Uganda, for hands-on experience to make products out of banana fiber, such as paper, woven cloth, etc. After the seminars and workshops participants' awareness was raised to the possibility for creating simple but income enabling industries using wasted raw materials. As the technology and know-how to extract the fibers are not of high-tech nature, the processes and opportunities could be easilv understood by all participants, nurturing hope and aspirations for job creation and sustainable living. Further to these activities, the team was able to discuss their findings with

the President and other high level officials of each country, on how best programmes could be designed to benefit from the technology. As a result, a follow-up mission comprised of 8 members of KIST and WDA, is intended to visit Japan to further engage the project in order to transfer this technology through establishment of pilot plants.



(16-29 January)

UNIDO-AOTS (The Association for Overseas Technical Scholarship) joint training programme; 27 Participants from 11 countries (Uganda, Ethiopia, Ghana, Cameroon, Kenya, Côte d'Ivoire, Zambia, Senegal, Tanzania, Malawi and South Africa) were trained on SMEs.

Ghana & SADC Training Programme on SMEs (27 February)

Joint programme with JICA; Roundtable meeting organized; 13 participants from 7 countries (Ghana, Zimbabwe, Lesotho, Malawi, Mauritius, Swaziland, Zambia) learned about SME policies and business promotion, as well as technology transfer from Japan. A discussion on actual hurdles in promotion were discussed with the involvement of diplomats from the countries based in Japan.



Training on Investment Promotion for Southeast Europe

(29 September-11 October)

Joint programme with JICA; 2 participants from Montenegro and 2 from Macedonia held 17 bilateral meetings for investment promotion in Tokyo, Nagoya and Osaka, and also were trained regarding Japanese business practices and COMFAR.

Japanese Descendant Training Programme

(13 November–9 December)

Joint programme with JICA; 2 participants from Peru & Brazil were trained on investment promotion skills and held 38 bilateral meetings in Tokyo, Hiroshima, and Oita.

Special Programme for Embassies

Networking in Japan (17 December)

9 Diplomats from Benin, Botswana, Egypt, Gabon, Kenya, Mongolia and Syria participated for training and discussion on practical know-how for business networking in Japan. Follow-up meetings and factory visits are planned.

Venezuela Business Executives

Fact Finding Mission to Japan (29 September – 6 October)

19 Executives taking part in an advanced management class at the IESA Business School and 1 faculty member of the school visited a waste processing plant in Tokyo and automotive engine manufacturing plant in Yokohama for fact finding and awareness raising on Japanese ecology and business methods.

Nigeria Mission

Fact Finding on Environment Protection Technologies (16-24 August)

Joint programme by UNIDO Nigeria and ITPO Tokyo; A 19-member mission made up of high level government lawmakers and members of the National Environmental Standards and Regulations Enforcement Agency (NESREA) held 20 meetings and factory/site visits relating to environment preservation technologies. As a result, a follow-up delegate programme for environment technologies from Nigeria is considered for 2009.

SME Policy and Promotion in Steel Industry (14-22 October)

A technical consultant on steel industry from Kyushu Techno Research was dispatched to Orissa State, India in cooperation with HQ; As a result, a follow-up policy recommendation report was completed, and "Eco-town" and steel slag processing projects are being planned.

SFF

Cleaner Production Promotion Visit & Roundtable (2 December)

8 Participants from Albania, Bosnia-Herzegovina, Moldova, and Serbia visited ITPO Tokyo and discussed about investment promotion programmes in Japan as well as environment related programmes and technologies. A staff of the NCPC Serbia was also part of the delegation. The delegate programme as a tool for promotion in Japan was explained.

South Africa

COEGA Fact Finding Visit and Roundtable (28 November)

A 7-member mission representing the COEGA Industrial Development Zone in South Africa visited ITPO Tokyo to discuss the potential of identifying Japanese institutions to lend HRD and industrial/operational training assistance to the zone, which is under construction and development. As a result, the possibility to invite a delegate from COEGA to Japan is being considered.

ITPO TOKYO SUCCESS STORIES - 2008

India (Orissa State): UNIDO and IPICOL cooperation to promote investment and technology from Japan **Counterparts:** DFID (UK); UNIDO HQ; IPICOL

《Situation Before》

The state of Orissa, situated on the east coast of India, boasting natural resources of iron ore and a promising steel industry, had been little promoted and less known in Japan. In 2006, the state institution IPICOL (Industrial Promotion and Investment Corporation of Orissa, Ltd.). and UNIDO, in cooperation with DFID, engaged the state in a series of capacity building and promotion programmes with various countries, including Japan. ITPO Tokyo started the project in November 2006 by fielding a fact finding visit to Orissa and to prepare implementation of the first promotion programme for Orissa in Japan. All activities were coordinated with UNIDO HQ, and UNIDO Delhi as well as respective embassies and organizations in Japan and India.

《Situation After》

Through the Orissa delegate programme, which

started in 2007, several Japanese companies in the steel and climate change (CDM) industries visited Orissa for surveys and bilateral business discussions through IPICOL, with a few project MoUs signed. In 2008 further activities included networking efforts by Orissa amongst Japanese business circles in India: a visit by a steel business mission from Japan to Orissa: the signing of a comprehensive MoU between IPICOL and JETRO for further promotion of ties; a follow-up delegates' visit from IPICOL to Japan; an assignment and visit of a Japanese steel/SME expert to a UNIDO project to survey SME downstream industries in Orissa. Through these activities, Orissa transformed its image in Japan, from a nonbusiness and almost non-existant one, to a business friendly destination for Japanese companies.



TICAD IV

The 4th Tokyo International Conference on African Development (28-30 May)

TICAD IV took place in Yokohama from 28 to 30 May 2008, gathering the Heads of States and Governments, and delegations of 51 African countries, together with the representatives of many other countries, international and regional organizations, private sectors, academic institutions and civil society organizations both from Africa and Asia.

The participants noted with sincere appreciation the continuing commitment of the Government of Japan, pertinent TICAD co-organizers and the international community to promote a "Vibrant Africa."

Boosting Economic Growth was one of the pillars of TICAD IV, and UNIDO vigorously participated in the Conference to contribute in the area of trade, investment, tourism and agriculture. The Director-General of UNIDO, Dr. Kandeh Yumkella, together with Mr. Yoshiteru Uramoto, Deputy Director-General, and Mr. Seiji Oshima, Head of ITPO Tokyo, tirelessly joined the Plenary Session and Side Events, including the following:

- Addressing Environmental Issues/Climate Change, Mitigation, Improving Energy Access
- Innovative Approaches to PSD for Achieving the MDGs in Africa co-hosted by UNDP/UNIDO/UNCTAD
- Technical Cooperation on Productivity Improvement in Africa by JPC/METI
- Breakfast meeting jointly hosted by UNIDO and JGC, inviting 200 persons amongst which the Presidents of Sierra Leone and Burundi attended.















TICAD IV also provided ITPO Tokyo with a golden opportunity to introduce one of its technology transfer programmes, i.e. Banana Textile. The students of the Banana Textile Unit of Tama Art University in Japan produced 10 traditional Happi Coats out of banana fiber, some from Africa. The coats were presented to the Presidents of Kenya, Tanzania, Rwanda, and Uganda. The national leaders were quite impressed with the quality of the textile, and urged ITPO Tokyo to promote the technology in Africa. Consequently, the Banana Textile Team visited Rwanda and Uganda to introduce the technology and products through seminars and workshops (see success story on page 10).
