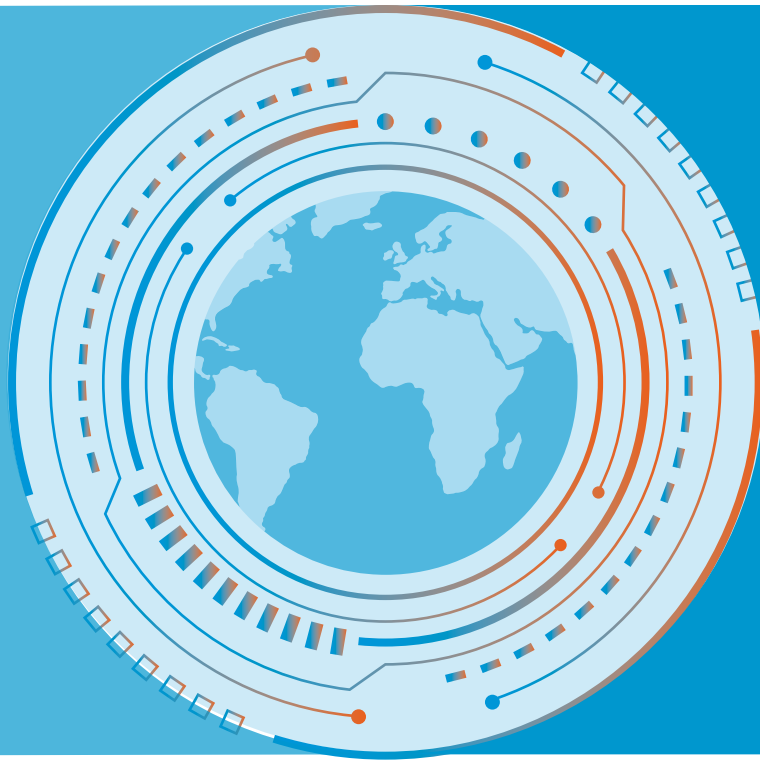

**UNIDO** is a specialized agency of the United Nations with a unique mandate to promote, dynamize and accelerate sustainable industrial development.

Our mandate is reflected in Sustainable Development Goal (SDG) 9: “Build resilient infrastructure, promote inclusive and sustainable industrialization, and foster innovation”, but UNIDO’s activities contribute to all the SDGs.

UNIDO’s vision is a world without poverty and hunger, where industry drives low-emission economies, improves living standards, and preserves the liveable environment for present and future generations, leaving no one behind.

UNIDO provides support to its 173 Member States through four mandated functions: technical coope-

ration; action-oriented research and policy-advisory services; normative standards-related activities; and fostering partnerships for knowledge and technology transfer.

Our work is concentrated on three focus areas: ending hunger by helping businesses from farm to fork; stopping climate breakdown by using renewable energy and energy efficiency to reduce industrial greenhouse gas emissions; and supporting sustainable supply chains so that producers in developing countries get a fair deal and scarce resources are preserved.

Since the establishment of UNIDO, Japan has played a crucial role as a key supporter of the Organization and largest governmental funding partner over the period 2019 to 2023, with voluntary contributions of \$66.2 million. The three projects launched at the below event, amounting to a total funding of \$3.3 million, complement further funding generously supported this year by the Ministry of Economy, Trade and Industry.

On 15 April 2024, UNIDO and the Permanent Mission of Japan to the International Organizations in Vienna launched three new projects funded by Japan at a kick-off ceremony held at the Vienna International Centre. UNIDO Director General Gerd Müller and Ambassador Atsushi Kaifu, the Permanent Representative of Japan to the International Organizations in Vienna, were joined by representatives from the partner countries Cameroon, the State of Palestine, and Ukraine to highlight the commitment to tripartite cooperation to address issues faced by communities in need.

Ambassador Kaifu stated “Today’s ceremony presents an opportunity for us to renew our commitment to working together for the stability and prosperity of the international community at a time of global hardship and uncertainty. Japan joins hands with UNIDO and each partner government to achieve the greatest possible outcomes for this purpose.”

Director General Müller thanked Japan for being “a very strong supporter of the kind of multilateralism the world needs,” praising “the long, close partnership between UNIDO and the Government of Japan and the country’s firm commitment to bringing sustainable development to our partner countries through UNIDO’s expertise, with its tangible impacts around the world.”

These projects, funded by Japan’s grant aid and the supplementary budget, underscore the continued shared commitment on the part of Japan and UNIDO to fostering inclusive and sustainable industrial development and to driving positive change worldwide. Through collaborative efforts and targeted interventions, they aim to empower communities, strengthen economies, and contribute to the achievement of the Sustainable Development Goals.

## DIRECTOR GENERAL MÜLLER'S VISIT TO JAPAN

In July 2024, UNIDO Director General Gerd Müller visited Japan to express appreciation for the long-standing relationship between UNIDO and Japan and to further strengthen cooperation to deliver high-impact projects for partner countries in areas such as industrial decarbonization, clean energy, food security, digital transformation, and the circular economy.

The Director General met with the Minister of Economy, Trade and Industry of Japan, Ken Saito, and stated his appreciation for the solid support of UNIDO's Investment and Technology Promotion Office in Tokyo for over 40 years as well as recent large-scale contributions which are funding two new major initiatives for the recovery in Ukraine and for sustainable development in countries of the Global South. A joint declaration was signed to strengthen collaboration through the successful implementation of the projects.

Yuko Yasunaga, Deputy to the Director General and Managing Director of UNIDO, and Fumio Adachi, Head of UNIDO ITPO Tokyo, who supported and accompanied the Director General during this mission, will lead the implementation of these significant projects.

During his visit, the Director General met with other important counterparts such as the Parliamentary Vice-Minister for Foreign Affairs of Japan, Hosaka Yasushi, with whom he discussed opportunities for increasing cooperation to support partner countries in the Global South and the forthcoming 9th Tokyo International Conference on African Development (TICAD) to be held in 2025 in Yokohama.

The Director General also met with the Chairman of the Japan External Trade Organization (JETRO) Norihiko

Ishiguro, and with high-ranking Japanese experts Michiharu Nakamura, Maki Kawai, and Yukari Takamura, as well as industrialist Kaori Fujita, and Member of Parliament Kuniko Inoguchi, to exchange views on sustainable industrial development.

# Delegate Programme

Investment and/or technology promotion delegates are invited for a short-term stay in Japan to hold business meetings and networking events with Japanese companies and government institutions to promote industrial development and technology transfer from Japan to the delegate's country.

Delegates are officials from government or semi-government institutions in developing and emerging countries, who are in charge of inviting FDI and/or technology transfer, with sufficient experience and good communication skills in English.

We help arrange business meetings with Japanese companies and organize investment seminars, promotional events, and factory and site visits. Through the programme, delegates will gain a better understanding of Japanese business culture in general and can establish direct connections to Japanese companies. In 2024, 12 delegates were invited from 10 countries.

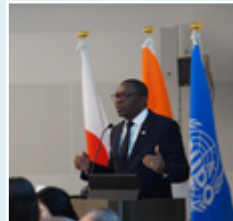

Government or semi-government institutions in developing and emerging countries may nominate candidates with the following qualifications:



**Substantive and/or management experience**



**Perfect command of spoken and written English**



**Strong negotiation and presentation skills**



**Ample knowledge of the local industries**



**Report writing and computer skills**

The details of the programme are decided based on the discussion between UNIDO ITPO Tokyo and the delegate's organization. Assistance includes invitation procedures, lodging subsidies, promotion of projects, identification of potential business partners, arrangement of meetings and visits, organization of seminars and roundtable meetings, assistance for business communication and negotiation, and provision of temporary office facilities. # Seminars and Events

In cooperation with government agencies and investment-related organizations of recipient countries, we organize seminars that focus on various countries and regions, such as in Asia, Africa, Latin America, and the Middle East. Such events focus on country information dissemination, networking, and business matching

between the Japanese private and public sectors and those from recipient countries, as well as exhibitions to introduce Japanese technologies to stakeholders overseas.

We provide detailed information on the latest local investment needs, investment regulations, opportunities, challenges, and incentives for Japanese companies, delivering accurate and reliable data and information in real-time.

After our seminars, we offer individual consultations to help network building in the field by matching with local government agencies and businesspeople through the UNIDO network in Africa, Asia, and other parts of the world. We also have locally based African Advisors who specialize in Africa.

## TAJIKISTAN BUSINESS SEMINAR

8 February, Tokyo, 21 participants



Held at the Embassy of the Republic of Tajikistan, the seminar focused on Tajikistan's **economic growth** and **key economic sectors** such as hydropower, agricultural processing, tourism, mining and processing of metals, stones, polymetallics, and construction materials, as well as **investment opportunities**.

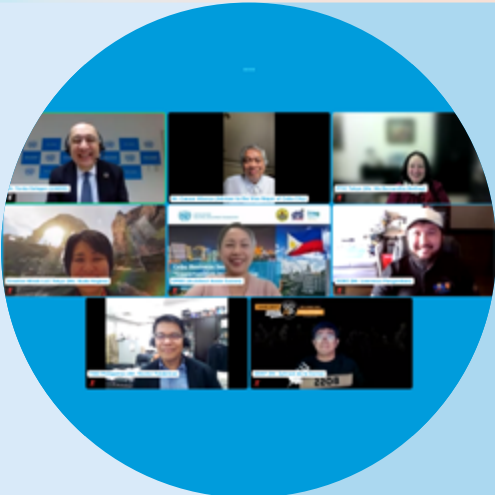
Japanese private sector speakers shared their experiences and challenges as well as future business perspectives in the country.

## CEBU BUSINESS SEMINAR - "OPPORTUNITIES IN THE CREATIVE INDUSTRIES"

29 February, Online, 91 participants



With the theme of "Opportunities in the Creative Industries" at its core, the seminar featured eight panellists and speakers from the private and public sectors involved in Cebu's **anime and game development industry**.

A government representative introduced the Creative Industries Development Act, which aims to **promote and support the creative industries**, while a city planning representative shared the vision of a modern and futuristic **Cebu City as a hub for creative industries**.



## EGYPT START-UP INVESTMENT/PARTNERSHIP WEBINAR "EXPLORING EGYPT'S INNOVATION AND START-UP ECOSYSTEM"

7 March, Online, 113 participants



Egypt's start-up ecosystem is one of the fastest growing in the MENA region, boasting a talented young population, resulting in the country having one of the top **ten most competitive talent pools** in the world. Especially in the areas of **e-commerce**, fintech, **health tech**, and **logistics digitalization**, the ecosystem plays a leading role in the country's innovation sector.

The webinar introduced Egypt's public-private organizations that support start-up businesses and highlighted business plans, including online pitches by eight Egyptian start-ups. Participants at the event included Japanese venture capital companies and innovation funds.



## CARICOM WEBINAR

14 May, Online, 81 participants



**CARICOM** is a regional organization comprising 14 Caribbean countries focused on economic integration, foreign policy coordination, and cooperation in social, cultural, and technological development. Member states, known as Small Island Developing States (SIDS), face **distinctive challenges due to their small land areas** and populations, geographical remoteness, natural disasters, and rising sea levels. In 2024, Japan and CARICOM celebrated significant anniversaries, including **60 years of diplomatic relations** with Jamaica and Trinidad and Tobago, and 30 years of Japan-CARICOM working-level consultations. To mark these milestones, UNIDO ITPO Tokyo hosted a webinar to introduce CARICOM's current situation and business opportunities to Japanese companies and organizations.



## TANZANIA INVESTMENT SEMINAR

28 May, Tokyo, 124 participants

31 May, Osaka, 72 participants



Held in two locations, the Tanzania Investment Seminar was organized with the Embassy of Tanzania in Tokyo and hosted 196 participants in total.

The country was introduced as a **promising hub in East Africa**, with its relatively **safe environment**, political and economic stability, rich **natural resources**, investment guarantees, and **strategic geography**.

Private sector representatives also presented their endeavours in the country.

During the coffee break, the panellists and participants engaged in lively networking, while enjoying exquisite "Kilimanjaro" coffee.



## CUBA BUSINESS AND INVESTMENT SEMINAR

4 June, Tokyo, 81 participants



Currently, more than 300 companies from over 40 nations invest in Cuba, and the country continues to offer new opportunities for FDI. The event helped promote the latest **foreign investment policies** and incentives in Cuba, as well as introducing famous **export products** with potential in the Japanese market such as coffee, cocoa, honey, coal, organic sugar, fruits, rum, and lobster.

Following the seminar, panellists and participants engaged in lively exchanges during a networking session, discussing potential business and investment opportunities and expanding networks while enjoying Cuban coffee and rum.



## JAPAN INTERNATIONAL AEROSPACE EXHIBITION 2024 SEMINAR

18 October, Tokyo, 80 participants



The Japan International Aerospace Exhibition is an event held in Japan every four years. In 2024, five aerospace experts from **India, Tunisia, South Africa, Morocco, and Viet Nam** were invited to take part in the event.

Activities, business meetings and presentations on the latest developments in aerospace-related business in the respective countries, together with the latest **trends, investment** opportunities, **procurement** opportunities and **incentives** in the aerospace sector.



## TÜRKIYE INVESTMENT SEMINAR

13 November, Tokyo, 166 participants



Marking the **100<sup>th</sup> anniversary** of diplomatic relations between Türkiye and Japan, UNIDO ITPO Tokyo, the Presidency of the Republic of Türkiye Investment Office and JETRO jointly organized the Türkiye-Japan Investment Forum at the United Nations University in Tokyo.

In this forum, the **investment environment and opportunities in Türkiye** were introduced, and two panel sessions highlighting the experiences of private and public sector companies and institutions emphasized the growing investment projects in the country.



## AFRICAN CONTINENTAL FREE TRADE AREA (AfCFTA) SEMINAR, CO-ORGANIZED BY JICA, UNDP, JETRO, AND UNIDO

21 November, Online, 265 participants



At this event, representatives from the AfCFTA Secretariat, UNDP and JICA gave a presentation and introduced the outline of AfCFTA, the current progress of its implementation, and prospects.

A panel discussion featuring a company representative in Africa and an official from JICA examined the **current situation of AfCFTA** and the **benefits** of utilising its framework, highlighting potential advantages for **Japanese companies**. The event was then closed by UNIDO ITPO Tokyo.

## EMBASSY TOUR

### Japan International Aerospace Exhibition 2024

17 October, 36 participants, Tokyo

Together with the Society of Japanese Aerospace Companies (SJAC), UNIDO ITPO Tokyo invited **36 delegates** from **26 embassies**, including **6 ambassadors**, to participate in a guided tour through the Japan International Aerospace Exhibition 2024 held at Tokyo Big Sight.

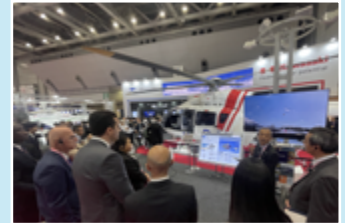
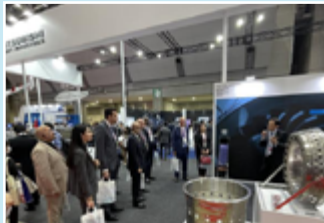
The aim of the tour was to learn about the innovations in operation, manufacturing and Maintenance, Repair and Overhaul (MRO) in the aviation and space fields, as well as specialties such as Urban Air Mobility (UAM) and decarbonization.

The invitees were divided into four groups and

accompanied to six company booths from major Japanese and international companies in the field.

“The diversity of the group participants emphasized the importance of international development and cooperation in aerospace technologies,” as stated during the welcome remarks by SJAC International Division’s General Manager, Mr. Minoru Hanakata.

This tour provided not only learning opportunities with the diplomats from developing and emerging countries but also created possibilities for developing business contacts and forming new networks in the field of aerospace technologies.

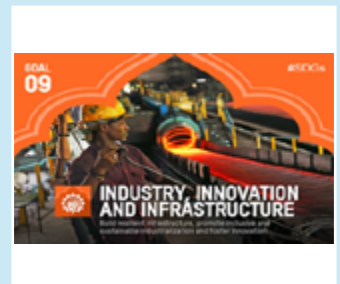

# Activities Overseas

UNIDO ITPO Tokyo facilitates business activities of Japanese companies overseas through a network of UNIDO, government, and private sector contacts in developing and emerging countries, as well as through the Africa Advisors Programme.



### ACTIVITIES HIGHLIGHT



## Factory Visit in Côte d'Ivoire, on the margins of The 3rd Japan Africa Public-Private Economic Forum

UNIDO ITPO Tokyo and UNIDO Côte d'Ivoire jointly organized a site tour (factory visit), in collaboration with the Ministry of Commerce and Industry of Côte d'Ivoire, for Japanese companies who participated in The 3rd Japan Africa Public-Private Economic Forum on 17 December 2024 in Abidjan.

A total of 33 participants from Japan, South Africa, France, Kenya, the UAE, and other countries participated in the tour and visited a flour mill of Les Moulins de Côte d'Ivoire (LMCI).

Both during and after the factory visit, a wide range of questions on topics such as mechanization, wages, the role of the government, food self-sufficiency rate, monetary union, energy, export destinations, and hygiene management, were asked by the participants. This was followed by a networking session in which all attendees engaged in lively exchanges.





# AFRICA ADVISORS PROGRAMME



## Results for 2024

Africa Advisors assisted **65+** Japanese companies

Since 2013, Africa Advisors have been assigned to support Japanese companies operating, or interested in starting a business on the continent. Our advisors provide a variety of services necessary for doing business in Africa, such as consultations for connecting with local businesses, arranging meetings with government agencies, matchmaking with local partners, and facilitating site visits to local companies.

Advisors are based in Senegal\*, Mozambique and Ethiopia as of 2024

*\*Senegal Advisor: active until 16 July 2024*

In 2024, three advisors, based in Ethiopia, Mozambique, and Senegal, covered seven countries (Burundi, Côte d'Ivoire, Ethiopia, Mozambique, Rwanda, Senegal, and Uganda). During the year, the advisors assisted more than 65 Japanese companies; some of them have already succeeded in concluding business agreements with local partners and establishing liaison offices.

## CÔTE D'IVOIRE AND SENEGAL

Aissatou Ndiaye, based in Senegal, cooperated with Japanese companies in the energy, ICT, construction, health, agribusiness, metals, automotive, food and consumer services, logistics, machinery, textiles, and water supply industries.

She also maintained interactions with ministries and government institutions, including respective embassies, chambers of commerce and industry, JICA, JETRO, and other sector institutions.



### Activity highlight: JETRO Mission to Côte d'Ivoire

Ndiaye participated in a business mission to Côte d'Ivoire organized by JETRO in February 2024. She presented the Africa Advisors Programme to the Japanese delegation members and local stakeholders such as an investment promotion agency, business associations, and ministries. Her mission led to the realization of the delegate programme in September and the site visit of a local company on the sidelines of the Japan-Africa Economic Forum in December.



## ETHIOPIA, RWANDA, UGANDA, BURUNDI

Tadesse Segni, based in Ethiopia, assisted Japanese companies in the telecommunications, agribusiness (including coffee), waste processing and management, clean energy, health care, education, and trade and investment sectors, among others. He also cooperated with local chambers of commerce and industry, government ministries, and respective embassies, as well as Japanese institutions such as JICA and JETRO.



### Activity highlight: Promotion of the Coffee Industry in Ethiopia

Following a webinar on Ethiopia's coffee industry held in 2023, Segni has continued to support specific initiatives by Japanese companies aimed at enhancing value addition in the sector. In 2024, a distributor was found for a STEPP-registered product after his introduction of demonstration equipment to local companies. Additionally, Segni has continued to provide on-site support for the efforts to commercialize and scale up high-value-added products developed in collaboration between a Japanese company and local producers.







# MOZAMBIQUE

Nandio Durao, based in Mozambique, promoted Japanese companies' businesses in alternative finance (blockchain), agribusiness, medical equipment, energy, venture capital, health (dental), construction, and ICT (safety and security) areas.

He further engaged with relevant ministries, embassies and chambers of commerce and industry, as well as Japanese institutions including JICA and JETRO.

## Activity highlight: Mozambique Sustainable Energy Seminar



The event attracted 118 participants. This seminar explained the national strategy of improving energy access. Durao contributed to the seamless flow of the seminar to introduce the enormous potential of large hydro and renewable energy in Mozambique. The panel discussion identified the importance of supplying competitive electricity to the manufacturing sector for industrialization and the need for establishing legal frameworks for renewable energy.



# TANZANIA (From February 2025)

Mr. Williard Kaaya is a certified accountant in both Tanzania and the UK with over 10 years of experience in auditing, taxation, financial management, business assessments, business management, local regulatory compliance, business processes and controls, as well as forensic investigations. He has extensive experience working with Japanese companies and entrepreneurs in Tanzania over the past six years. In his new role, he will be promoting business opportunities in Tanzania to the private sector in Japan and supporting Japanese companies already operating in Tanzania in collaboration with stakeholders such as TIC, Embassies, JICA, TPSF, and others.

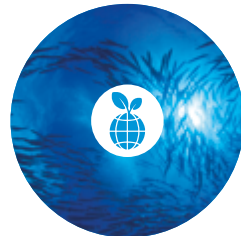

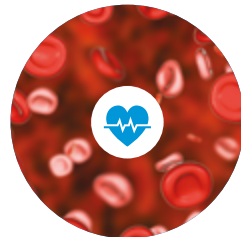

# Technology Seminars and Events



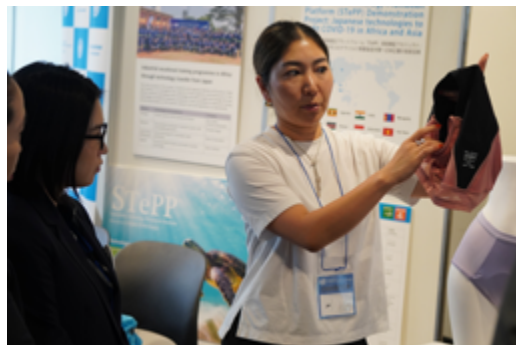
## The 4<sup>th</sup> Technology Day

The company presentations garnered much attention from the participants, and some were seen making appointments at the booth for follow up individual meetings with the companies.

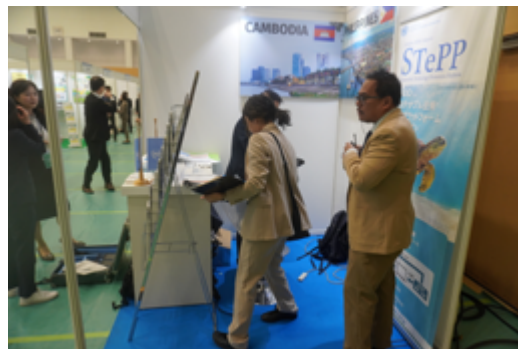




## 17<sup>th</sup> Kawasaki International Eco-Tech Fair

UNIDO ITPO Tokyo invited environmental experts from Cambodia and the Philippines to the fair. In addition to fruitful business sessions, the two delegates presented the current status and needs related to environmental technologies in their respective countries as part of the event ASEAN x EU Meet Up Day. # Participation in UNIDO Events



## WORLD WITHOUT HUNGER CONFERENCE

5 - 7 November, Addis Ababa

The three-day event was co-organized by UNIDO, the African Union Commission, and the Government of Ethiopia, with technical assistance from the Food and Agriculture Organization of the United Nations (FAO).

The aim of the conference was to accelerate the development of innovative technologies and sustainable practices to ensure food security for all by fostering collaboration among stakeholders. It brought together over 1,500 high-level stakeholders, including heads of state, ministers, UN agencies, and private sector individuals.

The ITP Network was invited to mobilize the private sector to the conference. UNIDO ITPO Tokyo mobilized various representatives of Japanese businesses, as well as collaborating with our advisor in Ethiopia (see page 32) to facilitate networking with conference participants.

All ITPOs were present at the conference and contributed by organizing a side event entitled “Bridging technology and investment: The ITP Networks’ approach” and sponsoring two booths where ITPOs’ activities were promoted. UNIDO ITPO Tokyo’s Head, Fumio Adachi introduced our activities at the ITP side event, such as STePP, and highlighted a STePP IVT project under implementation in Ethiopia which empowers women.

## ITPO HEADS MEETING

In May 2024, the UNIDO ITPOs Heads' Meeting, a yearly event bringing all ITPOs together to discuss strategy and coordination, was held in Manama under the initiative of the UNIDO ITPO Bahrain office, and moderated by Fatou Haidara, Deputy to the Director General and the Managing Director of the Directorate of Global Partnerships and External Relations, UNIDO and Hashim Hussein, Head, UNIDO ITPO Bahrain.

The meeting coincided with the World Entrepreneurs Investment Forum (WEIF) 2024.



## WORLD ENTREPRENEURS INVESTMENT FORUM 2024

The Forum was facilitated by UNIDO ITPO Bahrain, under the patronage of the royal family of the Kingdom of Bahrain.

With this year's theme "Achieving the SDGs through Fostering Innovation and Economic Growth", WEIF 2024 addressed global challenges, including poverty, inequality, climate change, peace, and justice.

UNIDO ITPO Tokyo took part in the ITPOs Panel on 15 May, "Leveraging the UNIDO Investment and Technology Promotion (ITPO) Network", where STePP and our other activities were presented to the forum participants.

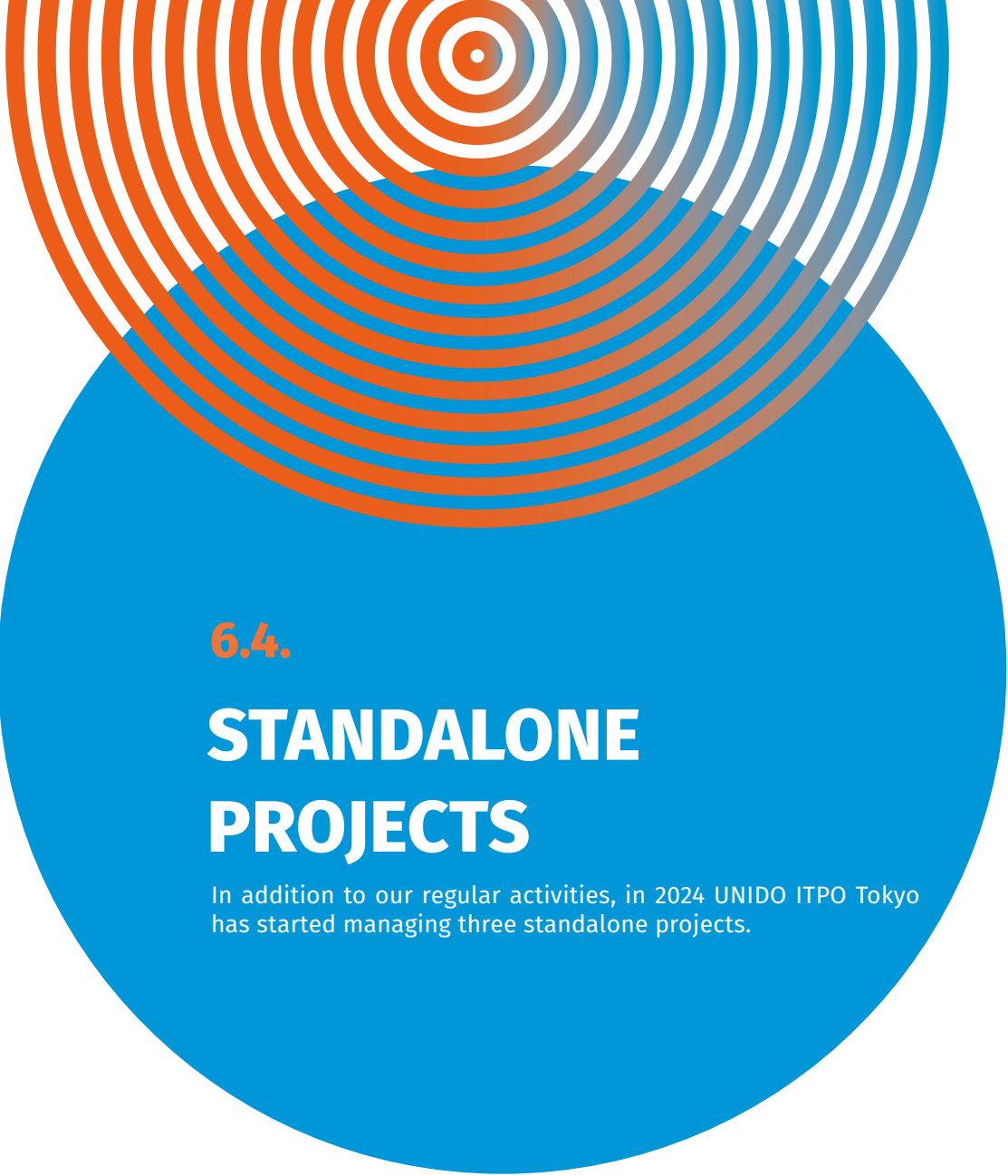

### ENTREPRENEURSHIP DEVELOPMENT PROGRAMME FOR UKRAINIAN WOMEN AND YOUTH IN JAPAN

UNIDO ITPO Tokyo cooperated throughout 2024 with UNIDO ITPO Bahrain to plan and implement this standalone project which resulted in training 75 displaced Ukrainian women and youth in Japan on entrepreneurship development, based on UNIDO ITPO Bahrain's EDIP modality. # Industrial Vocational Training Programme in Africa and Asia through Technology Transfer from Japan

In 2023, the “Industrial Vocational Training Programme in Africa and Asia through Technology Transfer from Japan”, funded by the Ministry of Economy, Trade and Industry (METI) was launched and expanded to include Asia with additional funding in 2024.

The programme aims to provide training to local engineers and technicians in Africa and Asia on technologies from Japanese companies that contribute to sustainable development and disseminate the newly acquired knowledge within the trainees’ home countries.

**This project is divided into two phases:**

**PHASE 1** – Training of Trainers (ToT): Instructors from participating countries are invited to Japan, and trained at selected Japanese companies in activities relevant to their technology/ specialty

**PHASE 2** – Local Training: Instructors return to their home countries and disseminate the acquired skills to local engineers and technicians

# HIGHLIGHTS FOR PHASE 1 - Training of Trainers



## KENYA

In October 2024, two trainees from the Nairobi Technical Training Institute were invited to Japan in order to learn about the end-of life vehicle recycling technology at Kaiho Industry, a company specializing in vehicle recycling.



## GHANA

Two trainees from Takoradi Technical University were invited to Japan for nine days to learn about environmentally-friendly pavement technology - inorganic soil hardening agent. This technology could be vital to Ghana's infrastructure, as roads account for the majority of logistics operations. Roads without pavement and unkempt roads are posing a threat to rural and farming communities due to shipment delays that result in major losses for farmers both in produce and in money.



## INDIA

Two trainees from Chandra Shekhar Azad University of Agriculture and Technology visited Mebiol Inc. to learn about the use of hydrofilm for farming purposes which enables soil-less farming. This technology can help support farmers in India faced with issues of access to water and fluctuations in the climate.



## MADAGASCAR

Two trainees visited Japan in order to learn about technology for rice husk conversion to solid fuel. This technology is of particular importance because it can mitigate the demand for firewood and charcoal which causes deforestation and other environmental problems. The trainees learned the technical aspects of solid fuel production, as well as safety and operation protocols. Upon their return home, the trainees will disseminate their knowledge through both theoretical and practical training sessions to 100 working professionals.



# HIGHLIGHTS FOR PHASE 2 - Local Training

## ★ MOROCCO

In April 2024, UNIDO ITPO Tokyo invited two trainees from Morocco to Japan, and with the support of Hinode Sangyo Co., Ltd., they successfully completed a two-week training program on promoting the skill development of engineers for wastewater treatment in Morocco.



## UGANDA

In May and June of 2024, two trainees from Uganda served as instructors to provide technical training to 100 local industrial personnel and trainees at Nakawa Vocational Training College on environmentally-friendly end-of-life vehicle recycling technology with real application of dismantling a vehicle.



## SOUTH AFRICA

In April 2024, two South African Trainees started their local training activities by organizing a call for local technicians and research students involved in sales in South Africa (and Botswana), after which they organizes three training programmes to accommodate 100 applicants.

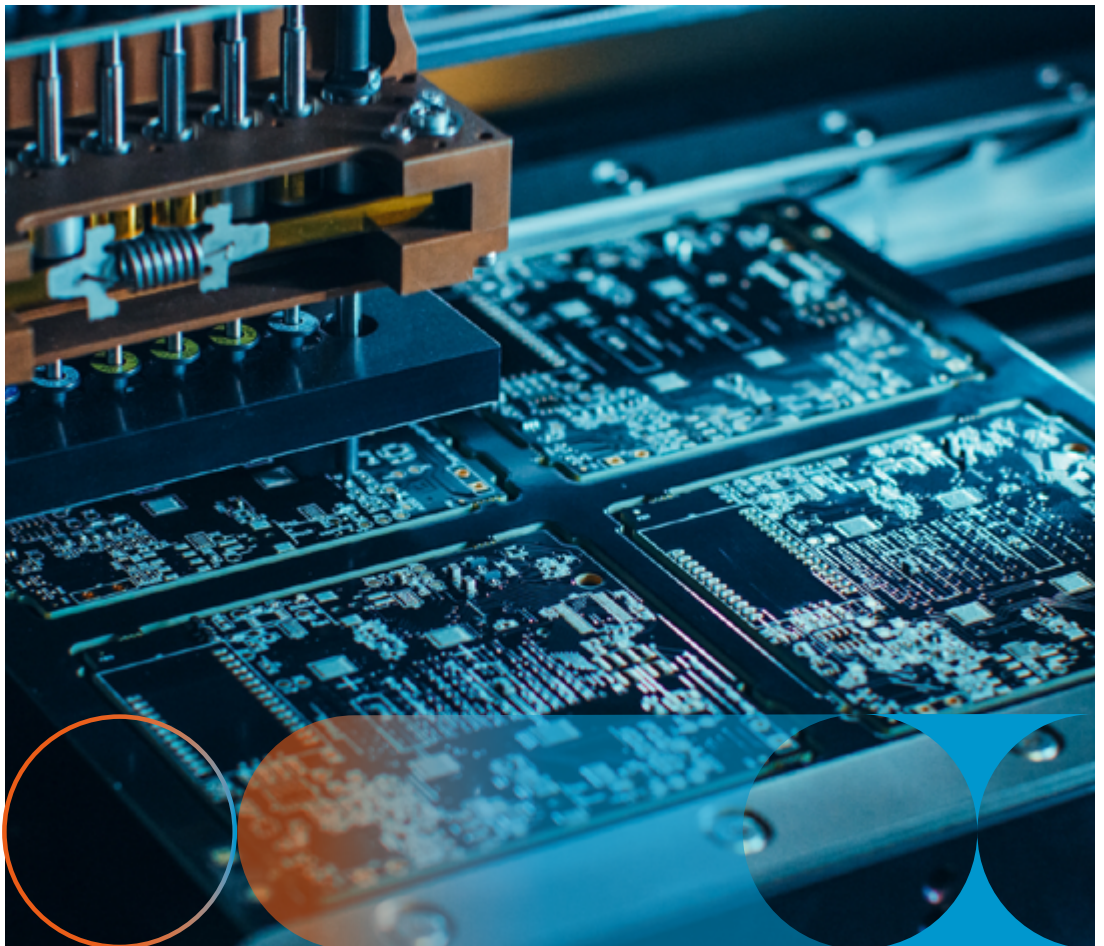
# Industrial Cooperation Programme in the Global South through Technology Transfer from Japan



UNIDO ITPO Tokyo is implementing a programme to promote technological innovation, strengthening supply chains and establishing industrial infrastructure in the Global South, through co-creation between Japanese companies and local partners. Japanese companies provide their effective and innovative technological solutions in the form of pilot demonstrations to address challenges currently faced by the Global South countries. (ASEAN countries are not included in this programme.)

The aim of this project, which is managed at UNIDO ITPO Tokyo, is to support the development of new businesses and employment opportunities in Global South countries through technology transfer and skills development from Japan, which include (but not limited to) fostering of innovation, strengthening of resilient value chains, and establishment of networks of industrial infrastructure in the implementation countries.

A call for proposals targeting Japanese companies was made in June 2024, and the selection process of companies taking part in the first batch was completed in December 2024. Additional calls for proposals will be made in 2025.

## Entrepreneurship Development Training for Ukrainian Women and Youth in Japan

Under the patronage of Japan's Ministry of Economy, Trade and Industry (METI), and in cooperation with UNIDO ITPO Bahrain, UNIDO ITPO Tokyo organized Entrepreneurship Development Training for Ukrainian Women and Youth in Japan, in two separate sessions in September.

The training programme was organized to support Ukrainian people living in Japan, particularly evacuees and university students, to become self-reliant by providing them with opportunities to learn entrepreneurship and relevant skills, enabling them to generate entrepreneurial ideas and business planning for new business creation and job finding in Japan.

At total of 75 participants from two sessions took part in the five-day intensive and interactive course consisting of lectures, discussions, entrepreneurs' panel, group work, presentation, learning reflection, and networking.

Subjects covered in the lectures included entrepreneurship from global as well as Japanese perspectives, ideation and storyline building exercises, strategy including franchising, start-up ecosystem, accounting, and relevant legal matters.

Upon completion of the programme, UNIDO ITPO Tokyo and UNIDO ITPO Bahrain organized individual counselling sessions for willing participants, offering thorough feedback on their business plans, and inviting guest entrepreneurs to provide advice.
