

Project for Development of the Construction Equipment Operator Training Centre

ACHIEVEMENTS

- The Ministry of Works and Transport (MoWT) has acquired the 10 acres of land on which the training centre will be constructed. The land title for Plot 60 on Block 717 in Bulemezi County, Luwero District, has been issued in the name of MoWT on July 23.
- UNIDO prolonged the request for quotation (RfQ) for the topographic survey due to missing GPS/KMZ data from the plot, which has been requested from MoWT. MoWT delivered the requested GPS/KMZ data to UNIDO.
- The Central Materials Laboratory at MoWT reviewed and cleared the Terms of Reference (ToR) for the geotechnical report.
- The project vehicle has arrived in Kampala. Customs clearance and all relevant administrative procedures have been completed. The stickers to show the Government of Japan's official assistance will be arranged accordingly.

PLANNED ACTIVITIES IN AUGUST 2020

- MoWT staff will demarcate the plot boundaries and notify UNIDO when the land is ready. UNIDO will be able to commence with the construction works once the formal notification/handover has been received from MoWT.
- For the topographic survey, UNIDO will conclude the RfQ, review all offers received and select a vendor.
- For the geotechnical report, UNIDO will conclude the RfQ, review all offers received and select a vendor.
- UNIDO will finalize the review of all applications for the Administrative and Financial Assistant position as well as the Construction Equipment Master trainer role. Candidates for both roles will be shortlisted.
