As you can see from this report, we have implemented various undertakings, including invitation of government officials as our investment promotion delegates, introduction of industrial technologies from Japan, and organization of seminars, workshops, and site or factory visits, amongst others. As expectations for technology transfer from Japan to developing countries are growing more than ever, especially in the fields of environment and energy where Japan has been playing a world leading role, ITPO Tokyo has embarked on new initiatives to meet those expectations. To mention just a few, we have begun to disseminate information of environment and energy related technologies owned by Japanese enterprises that are keen to undertake overseas operations. Also, UNIDO as a whole plans to organize a global forum on green industry promotion in Tokyo in 2011 in close cooperation with the government of Japan as well as Japanese industries.

The year 2011 marks the first year of ITPO Tokyo's new triennial project 2011-2013, which has just begun after the endorsement of the government of Japan and UNIDO. Furthermore, this year coincides with the 30th anniversary of ITPO Tokyo, since its inception in March 1981. At the beginning of this commemorative year, I reconfirm my commitment to do my utmost to fulfill all the missions assigned to us through actively seeking synergy with all our stakeholders more than ever.

- To accelerate the inflow of foreign direct investment from Japan to developing countries and economies in transition.
- To introduce new investment opportunities to Japanese enterprises and institutions through promotional activities.
- To provide consultation both to potential Japanese investors and to project sponsors in recipient countries
- To promote technology transfer with the aim of sustainable development.

UNIDO ITPO Tokyo's undertakings in 2010

- Invitation of government officials from 9 developing countries to Japan to be engaged in various promotional activities;
- Introduction of industrial technologies, like environment and renewable energy related technologies developed by Japanese companies and assistance for project formulation in developing countries;
- Organization of 11 site visits and/or study tours;
- Organization of or support to 40 investment and technology transfer seminars and workshops in different locations of Japan in close collaboration with government offices, industrial/business organizations, municipalities, chambers of commerce and industry, etc.;
- Dispatching of 19 consultancy missions overseas;
- Publication services such as the "UNIDO Investment News" (34 times) and the "UNI-World" newsletter (3 times).







Many developing countries can not always conduct investment promotion activities in Japan on their own, and UNIDO's office benefits such countries through its programmes and support.

The two week delegate programme gave me the opportunity to share information about the investment environment in Nigeria with a cross section of

Japan's automotive industry and to gain insight into factors likely to encourage flows of investment to Nigeria. I met with fifteen organisations including automotive manufacturers, component parts manufacturers/traders, automotive recycling companies, repair shops, a government trade support agency and the media. As a result, upon return to Nigeria, I have been able to draw up an action plan to pursue programme objectives in 2011.

Through meetings with professionals from the automotive, electronics, renewable energy and investment banking sectors, great interest has been expressed regarding Morocco's investment potential, with many immediate requests emerging from the visits. Cooperation and follow up with organizations

such as JCCME is also of utmost importance to capitalize on the momentum generated. The programme also allowed the delegate to sharpen and broaden his network, and deepen knowledge of the region's changing investment behavior.



During 10 days of joint promotion with AMDI, I was able to introduce my organization TMSA to Japanese corporations, and explain the advantages that the Tanger Free Zone & Port offers to Japanese companies, especially in the automotive and logistics industries.

Highlight — Promotion of Biofuel by African Delegates

One of the leading Japanese chemical companies started a Jatropha pilot plantation project in Tanzania in 2006. In April 2008, ITPO Tokyo invited Mr. John M. Mnali from Tanzania Investment Centre (TIC) as a delegate to further develop the project. Thanks to his efforts, the company has reached the decision to conduct a full-fledged feasibility study together with a local partner identified by TIC to expand its current operation. Meanwhile, the delegate programme succeeded in diversifying the project through the Green Africa Foundation (GAF) in Kenya. GAF is a well experienced NPO in the area of Jatropha plantation and extraction of oil, chaired by Mr. Isaac P. Kalua who also joined the delegate programme in 2009 and 2010 in order to consolidate the Jatropha project between Tanzania and Kenya. Mr. Guracha Adi, another delegate from Kenya Investment Authority (KenInvest) also supported the project in 2010

by providing regulatory, policy and logistical assistance. Through such project promotion, ITPO Tokyo is able to contribute to the development of each county, together with the relevant IPAs, and also in line with UNIDO's AfrIPANet (Africa Investment Promotion Agency Network http://www.afripanet.org) initiative

Technology Transfer



ITPO Tokyo promotes awareness and transfer of Japanese technologies to developing countries in order to assist them with viable and sustainable solutions for promoting employment, dealing with environmental problems, and offering alternative business models for industrial applications. The following are some of the technology sectors which were promoted in 2010.

Environment Fairs and Exhibitions

Kawasaki International Eco-Tech Fair 2010

(04-05 February)

Participated in the Fair with a UNIDO booth and introduced 9 diplomats to Japanese technologies exhibited.

Fuel Cell (FC) International Expo 2010

(03-05 March

Participated in the Expo together with UNIDO-ICHET (International Center for Hydrogen Energy Technologies), followed by bilateral meetings with the private and public sector.

Smart Grid and Auto Next Exhibition 2010

(16-18 June

Participated in the Exhibition to promote UNIDO's activities to the Japanese private and public sector.

Global Festa 2010

(02-03 October)

Participated in the Festa with a UNIDO booth and promoted SANYO's LED Lamp technology and Tottori Resource Recycling Laboratory's water saving irrigation technology.

Mass-Trans Innovation Japan 2010

(10 November

Participated in the exhibition to introduce Japanese railway technologies to 29 diplomats through a lecture and exhibit visit.

Agro Related Technologies

Banana Textile Workshop and Exhibition at Tama Art University

(19-31 January)

Tama Art University has extended its technical cooperation in Uganda, Rwanda, Ethiopia, India and the Philippines in the area of Banana Textiles through ITPO Tokyo's assistance.

EDS Feasibility Study in Nigeria

(20 February – 03 March)

EDS is an ecological timber drying system which can turn waste timber such as oil palm to usable building materials. EDS is negotiating a partnership to transfer the technology to Nigeria.

Riofuel Activities

The 'Green Investment in Kenya Seminar' was held at the Kenya Embassy with 45 participants and delegate Mr. Isaac P. Kalua of the Green Africa Foundation as a keynote speaker. (10 March)

The 'African Bio-fuel Seminar' was held during BioJapan 2010 together with the Japan Bioindustry Association and Nikkei BP, attracting 94 participants, including 4 diplomats and featuring Mr. Nam, Head of UNIDO ITPO Seoul as a guest speaker. (01 October)

One of the leading engine manufacturers of Japan donated 3 units of generator sets to Mali for a Jatropha project. The Jatropha oil production is expected to further develop through the assistance of CNESOLER (National Centre of Solar Energy and Renewable Energy), which has been cooperating with ITPO Tokyo through the delegate programme.

Steel Waste Recycling Technology in India



Highlight — Promotion of POPs and Waste Treatment Technologies

Persistent Organic Pollutants (POPs) are chemical substances that persist in the environment, bio-accumulate through the food web, and pose a risk of causing adverse effects to human health and the environment. Since 2008, ITPO Tokyo has supported UNIDO's activities in Japan under the Stockholm Convention and waste management programmes, by helping to identify leading Japanese technologies to help elimination of Persistent Organic Pollutants (POPs) in countries such as India, Nigeria, and the Philippines (i.e. Polychlorinated biphenyls – PCB-PCBs oil treatment in soil), and also help to deal with waste management, such as tackling e-waste in Russia (i.e. disposal of PCs and electronic equipment), and plastics waste recycling in India and introduction of bio-degradable plastics technology. Another area of activity concerns the promotion of industrial Eco-town management know-how, based on the rich experience of Japanese Eco-towns such as in Kitakyushu and Kawasaki cities. As a result of bilateral contacts and discussions held since 2008, UNIDO was able to sign an MOU with the City of Kitakyushu in June 2010 to further accelerate investment promotion of such technologies through training, site visits, and

delegate programme of UNIDO.

Several Japanese private sector companies and experts are now actively negotiating projects in the countries mentioned above, with technology transfer targeted in the years 2011-2012.



metal recycling technologies could be observed, by 62 African diplomats representing Algeria, Angola, Benin, Botswana, Burkina Faso, Cameroon, Cote d'Ivoire, D.R.Congo, Djibouti, Egypt, Eritrea, Ethiopia, Gabon, Ghana, Kenya, Lesotho, Liberia, Madagascar, Malawi, Mali, Mauritania, Morocco, Mozambique, Rwanda, Senegal, South Africa, Tanzania, Tunisia, Uganda, Zambia, and Zimbabwe.





Water and Energy Technology Site Visit and Meeting in Hiroshima

05 August,

In cooperation with the Chugoku Bureau of the Ministry of Economy, Trade and Industry, ITPO Tokyo organized the 2nd environment related tour and meeting, with 13 diplomats participating from Egypt, Ghana, India, Kenya, Malawi, Rwanda, Senegal, South Africa, Tunisia, and Yemen. Participants were able to witness water purification plant technologies and also engage in 20 bilateral business discussions with 6 companies from the region.



Round Table Meeting on "Energy Saving Railways Technologies" and visit to the 1st Exhibition on "Mass-Trans Innovation Japan 2010"

Highlight — Capacity Building on Japanese Railways Technologies (Embassy Programme)

The 'Mass-Trans Innovation Japan 2010' was held on 10-12 November in Makuhari Messe, Chiba, Japan. ITPO Tokyo in cooperation with the organizer Fuji Sankei Business i., and the Japan Railway Construction, Transport and Technology Agency (JRTT) invited 26 embassies of developing countries in Japan to attend a special roundtable meeting on "Energy Saving Railways Technologies" on 10 November. During the roundtable meeting, diplomats were able to listen to presentations highlighting the Japanese experience and technologies in this field. Recognizing the importance of the role of large scale infrastructure projects such as the Bullet Train (Shinkansen) and mass transit systems in the development of Japan from the 1950s through 1980s, participants engaged in discussion with Japanese experts about the ways and means to promote similar projects in their countries. A common theme emerging was the need to scale down or adapt projects to the technical and financial capabilities of each country. Recognizing this important challenge, Japanese experts expressed the Japanese public and private sector's commitment in helping developing countries identifying viable options for the introduction of train technologies, and also showed examples of recent projects undertaken, for example, a commuter train system in Dubai, UAE, and a metro train system

in Hong Kong. The presenters further welcomed individual approaches by developing countries interested in Japan's technologies. After the roundtable and discussion session, participants were led on a guided tour of the exhibition to see first hand the technologies on display.

Highlight — Bangladesh and ITPO Tokyo's Cooperation (*)

On 29 November, ITPO Tokyo co-hosted the "Bangladesh Business Seminar" with the Japan - Bangladesh Committee for Commercial and Economic Cooperation and JETRO, inviting the Honorable Prime Minister Sheikh Hasina as a key-note speaker. The event attracted 285 participants. ITPO Tokyo has almost 20 years of history of working with BOI Bangladesh ever since a BOI official was accommodated as a delegate in 1992. ITPO Tokyo and BOI Bangladesh, in close coordination with the Embassy of Bangladesh in Tokyo, have maintained strong cooperative ties through activities including organization of 6 delegate programmes for BOI officials, organization of 14 Bangladesh business seminars in several cities in Japan, and dispatch of a Japanese business mission in November 2009 comprising of 18 business people and 3 journalists. Such intensive and continuous efforts of ITPO Tokyo and BOI

Bangladesh have resulted in the conclusion of 13 Japanese investment projects in Bangladesh between 2008 and 2010.

India – Steel Slag Processing (08-12 March)

An expert from Kitakyushu Techno Research (KTR) visited New Delhi and Bhubaneswar in Orissa State to discuss business opportunities in steel slag recycling technologies.

Sri Lanka – Business Mission (12-20 September)

An ITPO Tokyo officer visited Sri Lanka to prepare for and lead a 10 member business mission to Sri Lanka representing the textiles, mining, banking, and securities sectors for business meetings and factory visits, organized in collaboration with BOI Sri Lanka, and UNIDO Sri Lanka.

An independent expert on 'wild silk' production was fielded to Botswana as a follow-up of the delegate programme to study the possibility for cultivation using know-how from Japan and other Asian

Algeria and Morocco - Fact Finding Mission (27 June - 07 July)

3 experts from the Japan Cooperation Center for the Middle East (JCCME) visited Algeria and Morocco, for which meeting coordination was arranged with the assistance of UNIDO Algeria and TMSA (through ITPO Tokyo's former delegate).

2 experts of a leading engine manufacturer re-visited Mali to finalize and settle the Jatropha generator project.

Highlight — Japanese Business Mission to Sri Lanka

In response to requests from the Japanese private sector, ITPO Tokyo, in cooperation with BOI Sri Lanka, fielded a 10 member business mission to Colombo during 15-17 September 2010, in order to observe the business climate and investment opportunities of the country. The mission members represented the textile/apparel, mining, banking and securities business sectors. One journalist also joined the mission. The mission met and discussed with high level officials of BOI Sri Lanka for possible ways of establishing a new business in the country, and visited Katunayake Export Processing Zone, Colombo Port, and 5 factories in the textile and electronics sectors. The mission also met with 30 existing Japanese investors, who shared their experiences in doing business in the country. The mission, which was coordinated with and supported by UNIDO Delhi and UNIDO Colombo, provided the participating members with a better understanding of the business potential of Sri Lanka as well as with an excellent opportunity to establish networks for

their future business in the country. As a result, some mission members are now considering projects in the country




Summary Report

UNIDO Director-General Kandeh K. Yumkella's Visit to Japan

(13-17 June 2010)

UNIDO Director-General, Kandeh K. Yumkella started a three day visit to Japan on 13 June 2010, at Sakai City in Osaka Prefecture, where he toured SHARP Corporation's "Green Front Sakai" complex and met with SHARP management to discuss technologies in photovoltaic cells and possibilities for collaboration in developing countries.

In Kitakyushu City in Fukuoka Prefecture, renowned for its advanced industrial and Eco-town complexes and technologies, Director-General Yumkella was briefed on efforts to promote Kitakyushu technologies in developing countries, particularly initiatives of the Kitakyushu Asian Center for Low Carbon Society. Later Director-General Yumkella met with Mayor Kenji Kitahashi, and officials of the city and discussed ongoing and future activities with UNIDO. A Memorandum of Understanding (MOU) was signed between UNIDO and Kitakyushu targeting promotion and sharing the experience of Kitakyushu in areas of environmental technology and waste recycling services with developing countries, including Eco-town management and treatment of Persistent Organic Pollutants (POPs). Director-General Yumkella also met with a delegation on environment technologies from Nigeria, led by Mrs. Ibukun Odusote, Permanent Secretary, Ecological Fund Office, who was taking part in one of the initial programmes covered by the agreement.



On 14 June, Director-General Yumkella held meetings in Tokyo, with Tadahiro Matsushita, Senior Vice Minister of the Ministry of Economy, Trade and Industry (METI); Nobumori Otani, Parliamentary Secretary of the Environment at the Ministry of Environment (MOE); and Osamu Fujimura, State Secretary for Foreign Affairs (MOFA).

In the meetings, topics of mutual interest were discussed, such as the Japan-UNIDO cooperation on environment and energy projects in developing countries, including Sub-Saharan Africa; cooperation on global environment issues; and findings of the UN Advisory Group on Energy and Climate Change (AGECC) chaired by the Director-General. On the same day,

Director-General Yumkella hosted a major seminar on Africa on the subject of "Potential and Business Opportunity in Africa" at the United Nations University (UNU). The seminar attracted about 350 participants from the public and private sector, as well as academia in Japan. The Director-General delivered a keynote speech titled "Self-sustainability of African Economy from Industrial Perspective". The seminar also included other keynote speeches, and a high level panel discussion on ways to increase business opportunity in Africa.





The Director-General's third and final day in Japan on 15 June comprised of several important meetings, highlighted by a breakfast meeting with Japanese public and private sector representatives, hosted by UNIDO's Goodwill Ambassador in Japan, Reinosuke Hara; a Press luncheon at the Foreign Correspondents' Club of Japan, attended by 50 press and invited members, where the AGECC report "Energy for a Sustainable Future", was presented by the Director-General; a meeting and speech at the Japan Association of Corporate Executives (Keizai Doyukai). The Director-General also visited ITPO Tokyo and met with the office's Head and staff, and attended a dinner hosted by Ambassador Sugiyama, Director General for Global Issues of the Ministry of Foreign Affairs. The Director-General departed Japan on 17 June.
